MEDICATION MANAGEMENT

POLICY & PROCEDURES

Purpose

To explain to parents/carers, staff and students the processes Ballarat Specialist School will follow to safely manage the provision of medication to students while at school or during school activities, including camps and excursions.

Scope

This policy applies to the administration of medication to all students. It does not apply to:

- The provision of medication for anaphylaxis which is provided for in our school's Anaphylaxis Policy
- The provision of medication for asthma which is provided for in our school's Asthma Policy
- Specialist procedures which may be required for complex medical care needs.

Implementation

If a student requires medication, Ballarat Specialist School encourages parents to arrange for the medication to be taken outside of school hours. However, Ballarat Specialist School understands that students may need to take medication at school or school activities. To support students to do so safely, Ballarat Specialist School will follow the procedures set out in this policy.

Authority to administer

If a student needs to take medication while at school or at a school activity:

- Parents/carers will need to fill out a 'Medication Authority Form' (Appendix A) to provide written advice to the school which details:
 - o the name of the medication required
 - o the dosage amount
 - o the time the medication is to be taken
 - o how the medication is to be taken
 - o the dates the medication is required, or whether it is an ongoing medication
 - how the medication should be stored.
- The principal or nominee may need to consult with parents/carers to clarify written advice and consider student's individual preferences regarding medication administration (which may also be provided for in a student's Student Health Support Plan).

Parents/carers can contact the school nurse for a Medication Authority Form.

Delivering medications to the school

- All medications need to be given by the parent/carer to a member of staff at the school. The only
 exception to this is where it has been agreed by the parent/carer and the school principal/school
 nurse that the child will carry their own emergency medication with them as part of the individual
 medical management plan.
- If the child is traveling to school on the school bus and the parent is unable to organise personal delivery of the medication to the school the parent needs to ensure that the bus chaperone is aware there is medication in the school bag and that the school bay is stored away from students during travel. The bus chaperone will give the bag containing medication to the staff member receiving the child off the bus informing the staff member of the presence of medication in the bag. The parent/carer should have alerted the class teacher to expect medication to be delivered the way on each occasion it occurs.

 Any medication that needs to be returned from the school to the parent /carer will also need to be transferred adult to adult. The class teacher will make appropriate arrangements with the child's parent/carer.

Medication Packaging

- Tablet type medication that is given on a regular should be packaged in a pharmacy provided 'webster' style packaging to reduce the risk of misadministration.
- Liquid/ cream/spray/aerosol type medications that can't be packed in a 'webster' style medication package must come to the school in its original packaging/container
- All medication/medication devices should have a pharmacy label where possible and the child's name clearly written on it.
- Parents/carers need to ensure that the medication a student has at school is within its expiry date.
 If school staff become aware that the medication a student has at school has expired, they will
 promptly contact the student's parents/carers who will need to arrange for medication within the
 expiry date to be provided.
- Loose medication are not acceptable and <u>will not be administered for safety reasons</u>. The school will contact the parent/carer in this instance.
- If for some reason there is a problem providing medication in the above described way the parent/carer must contact the school nurse to discuss the situation

Administering medication

If a student needs to take medication at school or during a school activity, the principal (or their nominee) will ensure that:

- 1. Medication is administered to the student in accordance with the Medication Authority Form so that:
 - the student receives their correct medication
 - in the proper dose
 - via the correct method (for example, inhaled or orally)
 - at the correct time of day
- 2. A log is kept of medicine administered to a student. (Appendix B)
- 3. Where possible, two staff members will supervise the administration of medication.

Self-administration

In some cases it may be appropriate for students to self-administer their medication. The principal or school nurse may consult with parents/carers and consider advice from the student's medical/health practitioner to determine whether to allow a student to self-administer their medication.

If the principal or school nurse decides to allow a student to self-administer their medication, the principal may require written acknowledgement from the student's medical/health practitioner, or the student's parents/carers that the student will self-administer their medication. This decision and plan will be documented in the student's records

Storing medication

The principal (or their nominee) will put in place arrangements so that medication is stored:

- securely to minimise risk to others
- in a place only accessible by staff who are responsible for administering the medication
- away from a classroom (unless quick access is required)
- away from first aid kits
- according to packet instructions, particularly in relation to temperature

For most students, Ballarat Specialist School will store student medication in a locked box kept in the classroom kitchen.

Ballarat Specialist School

The principal may decide, in consultation with parents/carers and/or on the advice of a student's treating medical/health practitioner:

- to allow the student to carry their own medication with them, preferably in the original packaging if:
 - o the medication does not have special storage requirements, such as refrigeration
 - o doing so does not create potentially unsafe access to the medication by other students

Warning

Ballarat Specialist School will not:

- in accordance with Department of Education and Training policy, store or administer analgesics such as aspirin and paracetamol as a standard first aid strategy as they can mask signs and symptoms of serious illness or injury
- allow a student to take their first <u>two</u> dose of a new medication at school in case of an allergic reaction. This should be done under the supervision of the student's parents, carers or health practitioner
- allow use of medication by anyone other than the prescribed student except in a life threatening emergency, for example if a student is having an asthma attack and their own puffer is not readily available.

Medication error

If a student takes medication incorrectly, staff will endeayour to:

Step	Action
1.	If required, follow first aid procedures outlined in the student's Health Support Plan or other
	medical management plan.
2.	Ring the Poisons Information Line, 13 11 26 and give details of the incident and the student.
3.	Act immediately upon their advice, such as calling Triple Zero "000" if advised to do so.
4.	Contact the student's parents/carers or emergency contact person to notify them of the
	medication error and action taken.
5.	Review medication management procedures at the school in light of the incident.

In the case of an emergency, school staff may call Triple Zero "000" for an ambulance at any time.
